- a) Approve and authorize the Chair to execute Amendment No. 3 to the Agreement for Services of Independent Contractor with Beacon Integrated Professional Resources DBA: Hamner, Jewell & Associates (a Tri-County vendor) to provide real property services for the Lower Mission Creek Flood Control Project, Reach 4 (BC 20-123), increasing the contract amount from \$228,100 to a not to exceed of \$293,400, an increase of \$65,300 and updating the Fee Schedule to current year rates;

Summary Text:

This item is on the agenda to approve Amendment No. 3 to the Agreement with Hamner, Jewell & Associates for real property services for Reach 4 for additional work necessary to complete the Lower Mission Creek Flood Control Project, Reach 4 (Attachment A). This project is in the City of Santa Barbara (City).

On August 18, 2020, the Board entered into an agreement with Hamner, Jewell & Associates for real property services for Reach 4 of the Lower Mission Creek Project (Attachment B). This agreement was subsequently amended by the Board on December 6, 2022 (Amendment 1) and by the Public Works Director, under Board authorization, on September 15, 2024 (Amendment 2), respectively resulting in a total contract amount of \$250,910 (\$228,100 plus contingency of \$22,810) and a term expiring on December 31, 2026 (Attachment C).

Hamner, Jewell & Associates actively coordinated and negotiated easement acquisitions necessary for the construction of Reach 4 of the Lower Mission Creek Flood Control Project. To date, easements across eight of nine properties (consisting of six permanent easements and eight temporary construction easements) have been obtained. Temporary agreements are typically required to have durations and end of date use clauses. Delays in the project beyond Hamner, Jewell & Associates' control, additional expenses outside of the original scope of work, including updating easement offers and negotiations to extend temporary agreements, require an increase in budget for the real property services contract to update and complete the easement actions for Reach 4. Delays in the project are primarily due to the Flood Control and Water Conservation District's (District's) responses to the 2023 and 2024 storm emergencies and associated budget impacts.

Background:

The Lower Mission Creek Flood Control Project is a federal, U.S. Army Corps of Engineers project and has been under development since the 1960s. The City and the District, acting as local sponsors for the federal project, worked with the community in the 1990s to develop the current project that addresses the flood control concerns and environmental issues.

In 2001, the City certified the Environmental Impact Report (EIR)/Environmental Impact Statement (EIS) and approved the project for Lower Mission Creek, as did the U.S Army Corps of Engineers after the City's approval. Since that time, federal funding for construction has not come forward and the City and the District have been working on finding opportunities to construct elements of the project as funding options arise. To date, the following project elements have been completed:
