## Recommended Action(s):

That the Board of Supervisors:

- A. Approve plans and specifications for Construction of 2005/2006 Regional Surface Transportation Program (RSTP) Augmentation Road Rehabilitation (Asphalt Concrete Overlay and Stress Absorbing Membrane Interlayer-SAMI) on Floradale Avenue in the 3<sup>rd</sup> Supervisorial District of Santa Barbara County, County Project No. 810524;
- B. Award the construction contract in the amount of \$424,812.50 to the lowest responsive bidder, Union Asphalt, Inc., a California Corporation (a local vendor), P.O. Box 1280, Santa Maria, CA 93456-1280, subject to the provisions of documents and certification, as set forth in the plans specifications applicable to the project and as required by law;
- C. Authorize the Chair to execute the construction contract upon return of the Contractor's executed contract documents and the review and approval of the County Counsel, Auditor-Controller, Risk Manager or their authorized representatives; and
- D. Approve a contingency fund in the amount of \$33,740.63 for Construction of 2005/2006 Regional Surface Transportation Program (RSTP) Augmentation Road Rehabilitation (Asphalt Concrete Overlay and Stress Absorbing Membrane Interlayer-SAMI) on Floradale Avenue in the 3<sup>rd</sup> Supervisorial District of Santa Barbara County, County Project Number 810524.

#### **Summary:**

On Thursday, August 31, 2006, one (1) bid was opened for the Construction of 2005/2006 Regional Surface Transportation Program (RSTP) Augmentation Road Rehabilitation (Asphalt Concrete Overlay and Stress Absorbing Membrane Interlayer-SAMI) on Floradale Avenue in the 3<sup>rd</sup> Supervisorial District of Santa Barbara County, County Project Number 810524. The bid was submitted by Union Asphalt, Inc., a California Corporation (a local vendor, with an office in Santa Maria), in the amount of \$424,812.50, which is 6.5% over the Engineer's Estimate. Five (5) contractors purchased plans and specifications for the project; however, due to the contractor's impacted schedules, the County only received one bid. Public Works staff has performed an analysis of the bid received and has determined that the bid is responsive and reasonable and recommends awarding this contract to Union Asphalt, Inc.

The proposed project is located in the unincorporated area west of the City of Lompoc and will resurface two (2) lane miles of Floradale Avenue from Ocean Avenue to 1.0 mile north of Ocean Avenue. The construction will consist of the repairs of failed pavement areas and placement of a Type B asphalt concrete overlay over a Stress Absorbing Membrane Interlayer (SAMI) and asphalt concrete leveling course. A separate, but concurrent, project will upgrade and repair the railroad crossing on Floradale Avenue. The upgrade and repairs to the railroad crossing is a joint venture between the Union Pacific Railroad Company and the County of Santa Barbara wherein the County is responsible for 50% of the overall rail road repairs cost.

This project was bid in accordance with the Public Contract Code, which requires the award to the lowest responsive bidder.

#### **Background:**

The specific project location was approved by your Board in FY 2006/07 Road Maintenance Annual Plan (RdMap) on March 28, 2006 and is part of the 2004 State Transportation Improvement Program Roadway Rehabilitation Project for which the County received partial funding for in Fiscal Year 2005/06.

Your Board also approved the project and CEQA Notice of Exemption on December 6, 2005 and the Reimbursement Agreement with Union Pacific Railroad for the upgrade and repair project was approved on August 1, 2006.

#### Fiscal and Facilities Impacts:

The total project funding, including contingencies, amounts to \$458,553.13 and is provided by (RSTP) Regional Surface Transportation Program.
