- V. PUBLIC COMMENT: Mr. and Mrs. Teixeira spoke to the Commission regarding their concerns of the position of the Rice Ranch Trail located behind their home. A site visit will be arranged with staff and Commissioner Mosby to further examine the trail and its position.
- VI. PARK COMMISSIONER'S NON-AGENDA ITEMS: None.
- VII. OPERATIONS AND FISCAL STATUS REPORTS: The Commission received and filed reports from staff.
- VIII. DIRECTOR'S REPORT AND BOARD OF SUPERVISORS HEARING SUMMARY:
  Paddy Langlands provided an update on the status of the Nojoqui Falls Trail and cleanup efforts
  at Orcutt Community Park. Revenues for events at Live Oak will be provided to the Commission
  at the next meeting. A future topic for discussion will be the option of renting out Cachuma Lake
  in its entirety for the Lucidity Festival. It is too late for the 2016 event but could potentially be an
  option in 2017.

# IX. QUIMBY FEES FOR RICE RANCH DEVELOPMENT - FOR ACTION

Staff presented their report to the Commission and recommended that the Park Commission find that the developer should be required to pay Quimby Fees (\$1.7M) for the following reasons:

- 1. The similarity of the current project being considered with that of the approved 2003 project that included both payment of fees and land dedication and improvement
- 2. The Board's ability to set requirements for dedications and fee payments
- 3. The precedent set by the fee agreement entered into in 2007 by the previous developer acknowledging Quimby Fee collection; and the ongoing capital funding needs for CSD-Parks.

Frances Romero presented on behalf of Rice Ranch Ventures and Shea Homes and respectively requested that the Park Commission consider the following options:

- 1. Recommend a waiver of 50% of Quimby fees to the Board of Supervisors based on park and open space investment to date.
- 2. Direct staff to work out a written agreement with the applicant, similar to the prior agreements, to leverage the Quimby fees for the provision to upgrade the Orcutt Community Park with improvements such as new synthetic turf on the sports fields, landscape rehabilitation and water saving irrigation enhancements.
- 3. Recommend a per unit donation to the Parks Foundation of 50% of Quimby fees as a special fund earmarked for the Orcutt Community Area or within the 4<sup>th</sup> District.
- ACTION: On a motion made by Commissioner Mosby and seconded by Commissioner Freeman, the Park Commission voted 5-0 to recommend a waiver of 50% of Quimby fees for the Rice Ranch Development to the Board of Supervisors.
