ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

Bradley Road south of Rice Ranch Road is designated as a major collector street in the Orcutt area. Pine Grove School is located at the corner of Bradley Road and Rice Ranch Road. Due to the limited parking at Pine Grove School, many of the parents that help out at the school have to park on Bradley Road in front of the school. Because these parked cars interfere with the drop-off and pick-up of students, the principal would like to see a portion of their frontage designated as a passenger loading zone. The California Highway Patrol is in support of establishing a passenger loading zone at Pine Grove School. Based on our review of the situation and the support of local law enforcement, it was determined that a passenger loading zone would be appropriate from 7 AM to 3 PM on school days only. The Public Works Traffic Section has prepared the attached resolution to establish a Passenger Loading Zone from 7 AM to 3 PM School Days Only at the following location:

• On the west side of Bradley Road, from a point 47 feet north of the centerline of Via Pavion to a point 182 feet north of the centerline of Via Pavion.
