



My husband and I manage a mobilehome park in Old Orcutt. We have had the pleasure of working with Waste Management for many years through a commercial account. At the beginning of May, we had to transition all our residents to individual residential accounts because of the changes in legislation last year. Transitioning 229 senior homes all at once to residential service is no small feat. Waste Management was extremely helpful through the entire process. We have created working relationships with WM employees that have really helped us to help our residents with as smooth of a transition as possible.

It has come to our attention that there is a possibility that WM's contract may not be renewed. I just wanted to reach out to voice my concern over another new transition for our park and our residents if that is the case. I respectfully request that the Board of Supervisors reconsider Staff's recommendations and continue negotiations with WM.
