

SIXTH AMENDMENT TO AGREEMENT FOR PROFESSIONAL LEGAL SERVICES

This Sixth Amendment to the Agreement for Professional Legal Services ("AGREEMENT") between the County of Santa Barbara ("COUNTY") and Rutan & Tucker, LLP ("ATTORNEY"), wherein ATTORNEY agrees to provide and COUNTY agrees to accept the services specified herein.

The parties hereby amend the AGREEMENT as follows:

Section 4, Term shall be revised to state:

ATTORNEY shall commence performance on April 9, 2019 and end performance upon completion of services, but no later than December 31, 2027, unless otherwise directed by COUNTY. This AGREEMENT may be earlier terminated by COUNTY as provided herein.

Section A of Exhibit B Payment Arrangements shall be revised to state:

A. For ATTORNEY services to be rendered under this AGREEMENT, ATTORNEY shall be paid a total contract amount, including cost reimbursements, not to exceed \$2,540,000.

The third paragraph of Attachment B-1 Schedule of Fees shall be revised to state:

Amounts to be charged to this AGREEMENT shall not exceed \$2,540,000 without further written authorization from COUNTY.

This Sixth Amendment may be executed in any number of counterparts and each of such counterparts shall for all purposes be deemed to be an original; and all such counterparts, or as many of them as the parties shall preserve undestroyed, shall together constitute one and the same instrument.

In all other respects, the AGREEMENT remains unchanged and in full effect.
