AMENDMENT NO. 1 to the MEMORANDUM OF UNDERSTANDING between

This Amendment No. 1 to the Memorandum of Understanding (MOU) executed on October 23, 2023, between the Santa Barbara County Association of Governments (hereafter "SBCAG), and the County of Santa Barbara (hereafter "COUNTY"), is hereby amended ("Amendment No. 1") as follows:

- Section 6, "Funding and Invoicing" subsection "A" is deleted and replaced in its entirety as follows:
 - A. SBCAG will contribute \$2,250,000 to SCCP funding for the Construction phase.
- 2. Exhibit D, "PROJECT Funding" is deleted and replaced in its entirety as follows:
