TO THE AGREEMENT WITH THE CALIFORNIA )  
DEPARTMENT OF INSURANCE TO CONDUCT AN )  
AUTOMOBILE INSURANCE FRAUD PROGRAM )

WHEREAS, the California Department of Insurance (CDI) distributes funds and administers a program for enhanced investigation and prosecution of automobile insurance fraud; and

WHEREAS, the District Attorney has the desire and capability to participate in efforts to deter automobile insurance fraud through enhanced investigation and prosecution; and

WHEREAS, on December 11, 2018, the Board of Supervisors adopted Resolution 18-306 authorizing the District Attorney to execute a Grant Agreement with the California Department of Insurance, to provide services for the period of July 1, 2018 through June 30, 2019 in the amount of \$115,000, plus \$6,787 in carryover from FY 17-18, for a total FY 18-19 allocation of \$121,787; and

WHEREAS, subsequent to this approval, the District Attorney was notified of an increase to the FY 18-19 award in the amount of \$52,900.

NOW, THEREFORE, BE IT RESOLVED that the District Attorney is authorized to execute a Grant Award Agreement Amendment with the California Department of Insurance, to provide services for the period of July 1, 2018 through June 30, 2019 in the amount of \$52,900, for a new total FY 18-19 award of \$167,900, plus \$6,787 in carryover, for a total FY 18-19 allocation of \$174,687; and

BE IT FURTHER RESOLVED that the State funds received hereunder shall not be used to supplant local funds that would be made available for this activity.
