### Fee Analysis and Methodology

- Activity-based cost analysis performed by Wohlford Consulting
- Analysis to determine the cost of providing fee-for-service activities is comprised of two basic elements:
  - Staff time spent to provide the service
  - Hourly rate of staff providing the service
- The product of staff time and the hourly rate yields the cost of providing the service.



## Fee Proposal Summary

Total Number of Fees	91
# Increased	66
# Decreased	14

New Fees Added	5
Current Fees Deleted/Restructured	16
Application Fees	Changed from 2 separate fees to a single fee of \$145
Hourly Fees	Changed from 5 separate hourly rates to a single rate of \$214 per hour






### New Standard Septic System






### Water Well Construction/Modification Permit

### Recommendations

On May 13, 2025

Adopt Resolutions Amending Fees For:

- Recreational Health (Public Swimming Pools)
- Onsite Wastewater Treatment Systems, Pumping, Maintenance and Disposal Services,
   Sewage Violation Inspections, and Land Development Review Services
- Organized Camps and Housing Complaint Inspections
- Body Art
- Public Water Systems (Safe Drinking Water Act)
- Water Wells and Private Water Systems



#### Recommendations

- Approve the introduction (First Reading) of Four Ordinances Amending Fees For: Solid Waste, Monitoring Wells and Borings, Site Mitigation, and Certified Unified Program Agency (CUPA);
- Read the titles of each of the said Ordinances and waive full reading of each of these Ordinances;
- Determine that the recommended action is exempt from the California Environmental Quality Act (CEQA) pursuant to Public Resources Code Section 21080(b)(8)(A) and (B) because the fees will be used for operating expenses and for the purchase of supplies, equipment and materials; and CEQA Guidelines Section 15273 because the proposed actions are administrative activities of the County, which will not result in direct or indirect physical changes in the environment and is therefore not a "Project" as defined for purposes of CEQA; and
- Continue the hearing to the Administrative Agenda of June 3, 2025 to consider adoption of the ordinance amendments
