

implementation costs. Project implementation costs were funded by a General Fund appropriation in the amount of \$400,000 that was set aside and approved in Fiscal Year 2017-18 in anticipation of the need to upgrade or replace the District Attorney's CMS. In FY 21-22, the purchase and implementation of the new system commenced, and the DA began incurring costs associated with the project. In FY 24-25, \$395,000 was funded and budgeted through the General County Programs General Fund for project costs associated with implementation and go-live. In December 2024, the new CMS went live, however \$50,000 of the funding and expenditures that were allocated for the purpose of system interfaces with other law enforcement agencies were unrealized in the fiscal year. This budget adjustment will reallocate the funding and expenditures in the amount of \$50,000 from FY 24-25 to FY 25-26 and the funds will be used for costs
