FY 2020/21 - Accept the 2017 Byrne Justice Assistance Grant (JAG) increase of \$46,700.

Budget Action: Increase appropriations of \$46,700 in the Sheriff General Fund for services and supplies (\$23,900) and capital assets (\$22,800) funded by unanticipated revenue from

Intergovernmental Revenue Federal.

Justification: assurances for the FY2017 Edward Byrne Memorial Justice Assistance Grant (JAG) with the United States Department of Justice (USDOJ). Santa Barbara County was awarded \$95,820 and will use the funds to acquire, upgrade and maintain equipment for the Santa Barbara Countywide Bomb Squad. \$46,700 will be spent in fiscal year In September 2017 the cities of Santa Barbara, Santa Maria and Lompoc each sighed interlocal agreements with the County of Santa Barbara to collectively use the funding for equipment and upgrades to the Countywide Bomb Squad. In June 2020 the Santa Barbara County CEO reviewed and signed the certifications and 2020/21: bomb trailer refurb \$3,600, communication equipment \$4,700, small tools & instruments \$15,600, special expenses, x-ray equipment, tech kits explosives and special ammunition and blasting supplies, detonating cords, lead in line, electrical matches, jib crane for trailer \$22,800. The remaining \$49,120 will be spent in fiscal year 2021/22 to acquire a Digital Hybrid Radio Control Assembly.
