PROJECT DESCRIPTION: Request for the Board of Supervisors to execute a professional services contract with MNS Engineers, Inc. (a local vendor) for professional engineering services for the design of a roundabout for the Santa Claus Lane Streetscape Improvement Project in the base contract amount of \$119,580. The contract is for preparing plans, specifications and estimate for the design of a roundabout on the Santa Claus Lane Streetscape Improvement Project. The roundabout is part of a master plan for the entire length of Santa Claus Lane, focused on improving public safety, formalizing and increasing parking, improving multi-modal circulation, managing storm water runoff and improving aesthetics within the project area.


