SUBJECT: No Parking Zones on Burton Mesa Boulevard in the Fourth Supervisorial District.

**RECOMMENDATIONS:**

That the Board of Supervisors adopt a resolution establishing "No Parking" zones on Burton Mesa Blvd. in the Lompoc area.

**ALIGNMENT WITH BOARD STRATEGIC PLAN:**

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

**EXECUTIVE SUMMARY & DISCUSSION:**

Burton Mesa Boulevard is a major-collector type road that extends eastward from State Route 1. The Heritage Oaks Senior Center has requested that a "No Parking" zone be installed on the south side of Burton Mesa Boulevard due to very large trucks and trailers parking near the entrance to their facility. Based upon our investigation of this site, it was determined that by restricting parking at this location (see vicinity map), sight distance will be improved for motorists exiting the senior center. The Public Works Traffic Section has prepared the attached resolution to establish a "No Parking" zone at the following locations:

- On the south side of Burton Mesa Boulevard, from a point 362 feet east of the centerline of Mesa Circle Drive (East) to a point 188 feet west of the centerline of Mesa Circle Drive (East).
