Dear Board of Supervisors,

I strongly request that you strongly reconsider and stop the approval of the TRRP. Stop it despite the momentum behind it, despite the 'emergency' status and/or the perception of having to do something, anything, this, fast.

Planning for the project was started so long ago that new solutions have evolved that are superior environmentally and financially to this project. It is inappropriate on a coastline with multiple elements that have become more endangered in the last twenty years, from species to the quality of the Channel. They are jeopardized in large or small part by this project, but every part, even if it is small, is cumulative.

There is a saying in the Audubon Society, of which I am an active member. Every bird counts. Providing for that bird also provides for the less visible or notable species that surround it, its habitat, and the larger habitat of which it is a part. Every bird, plant, stream, tree, frog... they all count.

There is much momentum for the TRRP in the work, time, funds that have gone into its planning by the Planning Department, by those entities with an investment. That is not good reason to go with this project. There are other and better solutions before you. There are experts who know what they're doing, and strongly advise against it. There is our responsibility to preserve and restore what cannot be replaced, and the Gaviota Coast certainly qualifies as a unique, biologically rich, and scarce "last stand" on the California Coast. It is not ours to develop. It is ours to protect. This 1967 landfill is ours to restore.

Have the alternative proposals to the TRRP's purported reduction of greenhouse gases or other benefits been evaluated any time recently against other projects?
