Recommended Actions: Approve the appointment of Joan Jamieson as the City of Solvang representative to the Indian Gaming Local Community Benefit Committee for the term of July 1, 2009-February 1, 2010.

Summary Text:

The Board of Supervisors appointed Linda Jackson as the City of Solvang representative to the Indian Gaming Local Community Benefit Committee ("Committee") on February 3, 2009. However, due to a resignation, on June 8, 2009, the City of Solvang Council appointed Joan Jamieson as its representative. The County Board of Supervisors is required via Statute, Government Code Section 12715(2)(B), to approve the City of Solvang appointment to the Committee.

Background:

Senate Bill 621, chaptered into law in 2003, establishes an Indian Gaming Local Community Benefit Committee ("Committee") in each county where Indian gaming is conducted. The primary purpose of the Committee is to select grants to support local government agencies impacted by tribal gaming using funds from the Tribal Gaming Casino Account. Per Assembly Bill 158, chaptered into law in 2008, the City of Solvang shall have only one representative on the Committee. The current Committee configuration includes two members from the Santa Ynez Band of Chumash Indians, two members from the County Board of Supervisors, one City of Solvang representative and two at-large members.
