WHEREAS, the Redevelopment Plan for Isla Vista identified a goal to promote public improvement facilities which are sensitive to the unique environmental qualities of the Project Area and improve conditions of deficient infrastructure; and

WHEREAS, on August 21, 2007, the Board of Supervisors adopted the Isla Vista Master Plan which identifies policies and action items aimed at alleviating existing parking constraints in the downtown business district and encourages the construction of downtown parking lots and installation of downtown parking meters; and

WHEREAS, on June 3, 2008, the Redevelopment Agency of the County of Santa Barbara ("Agency") was authorized to purchase and develop the real property located at 881 Embarcadero Del Mar (the "Property") in the Isla Vista Project Area ("Project Area") as a public parking lot; and

WHEREAS, on September 1, 2009, the Board of Directors of the Redevelopment Agency of the County of Santa Barbara authorized the County to operate a parking program on parking lots owned by the Redevelopment Agency and located within the boundaries of the Isla Vista Master Plan ("Redevelopment Agency Parking Lots"); and

WHEREAS, on even date herewith, the Board of Supervisors adopted an Ordinance adding Chapter 23E to the Santa Barbara County Code Regarding Parking Lot Meters; and

WHEREAS, charging a reasonable fee for parking in the Redevelopment Agency Parking Lots in Isla Vista will support downtown commercial viability by increasing turnover of parked vehicles thereby increasing the supply of short-term parking; and

WHEREAS, charging a reasonable fee for parking in the Redevelopment Agency Lots would generate revenue to assist in the acquisition and development of more properties for use as parking; and

WHEREAS, the Board of Supervisors now desires to establish a fee structure for parking spaces within the Agency Parking Lots.

NOW, THEREFORE BE IT FOUND AND RESOLVED by the County of Santa Barbara Board of Supervisors as follows:

- a. The above recitations are true and correct.
- b. The Board of Supervisors hereby sets the downtown Parking Lot Meter fees as set forth below:
