That the Board of Supervisors:

Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, Granite Construction Company, Inc. (Not a Local Vendor), Post Office Box 50085, Watsonville, California 95077, in the amount of \$1,548,227.28.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

The project consisted of concrete repair and surface treatment. The concrete repair included the removal and replacement of damaged concrete curbs, gutters and sidewalks, and tree root pruning and shielding. Approximately 400 linear feet of curb & gutter and sidewalk was repaired. The surface treatment included the rehabilitation and asphalt concrete overlay of the existing roadways. This repair also included removing and repairing failed areas in the existing pavement. Approximately 8.0 lane miles of County maintained roadway was repaired and resurfaced with this project.

The Director of Public Works accepted this project as complete on September 5, 2003.

The project was bid in accordance with the Public Contract Code, which requires the Department to award to the lowest responsible bidder.

The project was completed on time and under the allotted contract amount.
