AMENDMENT NO. 3 TO THE AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR WITH GEOSYNTEC CONSULTANTS INC. (BC No. 22-063)

Pursuant to Paragraph 25 of the Agreement for Services of Independent Contractor (hereinafter AGREEMENT) entered into on July 12, 2022, as BC No. 22-063, between the County of Santa Barbara (hereafter COUNTY), and Geosyntec Consultants having its principal place of business at 924 Anacapa, STE 4A, Santa Barbara, CA 93101 (hereafter CONTRACTOR), the COUNTY and CONTRACTOR amend the AGREEMENT as follows:

1. Exhibit A, Statement of Work is hereby amended to include:

Work as described in the attached Statement of Work from CONTRACTOR, attached as **EXHIBIT A2**, incorporated by this reference.

2. Exhibit B, paragraphs A and C are hereby amended to read:

- A. For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed \$556,629.
- C. Payment for services and /or reimbursement of costs shall be made upon CONTRACTOR's satisfactory performance, based upon the scope and methodology contained in **EXHIBIT A, EXHIBIT A1, and A2** as determined by COUNTY. Payment for services and/or reimbursement of costs shall be based upon the costs, expenses, overhead charges and hourly rates for personnel, as defined in **Attachment B1** (Schedule of Fees). Invoices submitted for payment that are based upon **Attachment B1** must contain sufficient detail to enable an audit of the charges and provide supporting documentation if so specified in **EXHIBIT A1, and EXHIBIT A2**.

In all other respects, the AGREEMENT, as previously amended, remains unchanged and in full effect.

Additional Services Scope and Budget

Follow up to our discussions during our July 2023 meetings, we prepared this description of additional scope and budget request to address the additional effort to be performed during August and September of 2023 to complete design and support the bid of the subject project.

Estimated Add-On Effort:

- Task 1 Add-On Project Management (PM) Services:
 - The existing scope of work assumes that the engineering services effort will be completed by end of July 2023 (i.e., a 12-month project period). At this time, it is anticipated that construction will start in early October 2023. At County's request, Geosyntec will continue to provide the applicable PM services through this additional 2month period.
- Task 7 Add-On Services for Bid Support:
 - Under the original project delivery approach, the County intended that the selected construction contractor would furnish, deliver, and install/construct all components of the new OWS system. As an updated delivery approach and in the interest of the project implementation schedule, since 2nd quarter 2023 the County decided to self-procure select equipment (i.e., generally, long lead items). This updated approach requires Geosyntec to prepare materials for standalone bid/quote packages for the County-procured equipment.
 - For better planning and to manage the procurement and bidding processes, mainly for the County procured items, the County has requested Geosyntec to prepare an estimated construction schedule. This will be an add-on task to our existing scope of work.

The above listed add-on effort is estimated to be completed for the fee of \$18,152.
