On October 9, 2012, set a hearing for October 16, 2012 to consider Case No. 12APL-00000-00015, the appeal filed by Marc Chytilo on behalf of the San Antonio Creek Homeowners Association and Channel Islands Chapter of the California Native Plant Society of the County Planning Commission's approval of the Park Hill Estates v.2 project, Case No. 10TRM-00000-00001.

On October 16, 2012, your Board should consider the following actions:

- 1. Deny the appeal, Case No. 12APL-00000-00015, thereby affirming the County Planning Commission's approval of the project, case number 10TRM-00000-00001, as shown in the Planning Commission Action Letter, dated September 10, 2012;
- 2. Make the required findings for approval of the project, including CEQA findings;
- 3. Adopt the Proposed Revised Final Mitigated Negative Declaration and adopt the mitigation monitoring program contained in the conditions of approval; and
- 4. Grant de novo approval of Case No. 10TRM-00000-00001, subject to the conditions of approval.

The project site is located at 4700 Via Los Santos in the Goleta area, 2nd Supervisorial District. The applications involve AP No. 059-290-041.
