Justification:

In November of 2012, the Board awarded contracts to begin construction of Phase One of the New Cuyama Family Resource Center and Library. Because of the nature of this modular building construction, the project used two bid packages; one for the modular work being currently performed by API Inc., and one for the site work, currently being performed by Quincon.

The Cuyama Valley Family Resource Center (CVFRC, a local 501(c)3 entity) has obtained grant funding totaling \$370,000. The CVFRC has agreed to donate this funding to the County in order to complete Phase II of the project.

This budget revision request will provide the appropriations necessary to accept the donation and fund completion of the project.
