That the Board of Supervisors:

- a) Approve, ratify, and authorize the Chair to execute a Participation Agreement (PA) with the California Mental Health Services Authority (CalMHSA) for the Quality Measures and Performance Improvement Program for the fixed rate of \$25,000 and additional Healthcare Effectiveness Data and Information Sets costs not to exceed \$5,000 over the fixed rate, for a maximum agreement amount of \$30,000 from February 7, 2024, to December 31, 2024;
- b) Delegate to the Director of the Department of Behavioral Wellness or designee the authority to adjust Program timelines and technical requirements per Exhibit A of the Agreement and approve of additional analysis of the Healthcare Effectiveness Data and Information Set (HEDIS) data per Exhibit B, all without altering the maximum agreement amount and without requiring the Board's approval of an amendment of the Agreement, subject to the Board's ability to rescind this delegated authority at any time; and
- c) Determine that the above actions are government funding mechanisms or other government fiscal activities that do not involve any commitment to any specific project that may result in a potentially significant physical impact on the environment and are therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(4) of the CEQA Guidelines.

Summary Text:

This item is on the agenda to request the Board of Supervisors (Board) to approve, ratify, and authorize the Chair to enter into a Participation Agreement with California Mental Health Services Authority (CalMHSA) from February 7, 2024, to December 31, 2024, to meet the Healthcare Effectiveness Data and Information Sets (HEDIS) reporting requirements for Measurement Year 2023. The data will examine five required Mental Health Plan (MHP) measures and four required Drug Medi-Cal Organized Delivery System (DMC-ODS) measures. Data measured will provide an informed analysis of Behavioral Wellness service delivery based on the National Committee on Quality Assurance proprietary measure specification. BWell will pay a fixed fee for service of \$25,000 and up to an additional \$5,000 for further data analysis of the HEDIS data for a maximum agreement amount of \$30,000 from February 7, 2024, through December 31, 2024.

Background:

In 2014, the Board of Supervisors approved Behavioral Wellness's membership in California Mental Health Services Authority. CalMHSA provides fiscal or administrative services for its members including contract management, research and development, data management, maintenance of a research depository, technical assistance, capacity building, group purchasing, education, training, and the execution of policy requests.

The Quality Measures and Performance Improvement Program ("Program") will support BWell in meeting the HEDIS reporting requirements for Measurement Year (MY) 2023.

CalMHSA will utilize data provided by BWell to calculate the five required Mental Health Plan measures and four required Drug Medi-Cal Organized Delivery System measures. BWell data will include eligibility, service and claims data, including Medi-Cal Master Eligibility Files, Managed Care Plan claims data, pharmacy claims, Behavioral Health Plan claims or service data, and Fee for Service claims. All data will be transferred via secure file transfer, and/or, with previous authorization, will be retrieved from the Department of Health Care Services Plan Data Feed MoveIT SFTP folder, and/or from BWell's SmartCare Electronic Health Record directly from SmartCare.

CalMHSA will utilize the National Committee on Quality Assurance ("NCQA") proprietary measure specifications to inform the analysis and will provide BWell with the results of the analysis of performance on the relevant measures. CalMHSA will provide additional information to DHCS and/or the California External Quality Review Organization (CalEQRO) if requested by BWell. Additionally, CalMHSA will host webinars for Participants to support Participants in orienting to HEDIS measurement and related performance improvement strategies.

BWell will pay the CalMHSA set fee for service of \$25,000. If BWell chooses to request additional analysis, each analysis will be charged \$1,000. BWell is budgeting for a maximum of five additional data analyses of the HEDIS data. BWell began negotiating this agreement in April 2024. The maximum agreement amount of \$30,000 will cover the analysis from February 7, 2024, through December 31, 2024.
