County Counsel announced the following:

By a vote of 5:0, the BOS authorized CC to initiate litigation against the performance bond company ARCH to compel completion of the Landscaping/grading conditions in the Mesa Verde subdivision.

On April 2, 2013, we reported out from closed session that by a vote of 5:0, the Board of Supervisors authorized the Chair to execute negotiated settlement agreements with all cities in the County to resolve the Property Tax Administration Fee dispute decided by the California Supreme Court in the City of Alhambra v. County of Los Angeles case. At that time, we said that the settlement agreements would not be final until formally executed by each City. Each City has now executed its respective settlement agreement and the settlements are now final. The County paid a total of \$3,192,159 to settle this dispute, covering disputed amounts beginning in fiscal year 2006-07 and continuing through fiscal year 2011-12.
