# **Alignment with Board Strategic Plan:**

The recommendation is primarily aligned with Goal No. 1. An Efficient Government Able to Respond Effectively to the Needs of the Community.

# **Executive Summary and Discussion:**

The County Public Works Department has designed the plans and specifications to install and construct new sidewalk and street tree improvements on the north block of Sabado Tarde Road between UCSB and El Embarcadero in connection with the Isla Vista Sidewalk Project.

On January 22, 2002, the County Board of Supervisors adopted Resolution 02-031 establishing compensation for the Isla Vista Sidewalk Project of twenty dollars (\$20.00) per square foot of easement area conveyed (Clerk of the Board File No. 02-00103).

The property owners listed above have executed the attached <u>Permanent Easement Purchase and Temporary Entry Contracts</u> and <u>Easement Deeds</u> for the purposes of conveying the necessary rights and easements to the County necessary for construction of the sidewalk and street tree improvements.

The owners are being compensated in the amounts listed above in the "Recommendations" section of this board letter depending on the amount of square feet of easement area conveyed to the County. In some cases, additional compensation has been required due to the loss of trees, landscaping, patio space, and other improvements.

In the case of the vacant lot on northeast corner of Sabado Tarde and El Embarcadero (APN 075-173-023) the property owner, Nettie Karras, has agreed to convey the easement to the County in exchange for the installation of the sidewalk and street tree improvements at the County's cost, but without monetary compensation. This is being done in part because the existing CUP on the property requires the subject easement to be conveyed to the County without monetary compensation and in part because the installation of the sidewalk and street trees at the County's cost will make it unnecessary for a future developer of the property to install the improvements on the property at their own cost.

Payment to the property owners will be made within thirty (30) days of recordation of the permanent easements by the County.

On Monday, April 24<sup>th</sup>, the Coastal Development Permit for the sidewalk project was approved by the County's Zoning Administrator. On Wednesday, May 3<sup>rd</sup>, the project and the easement acquisitions were found to be in conformity with the County's General Plan in accordance with Government Code Section 65402.
