

MEMORANDUM OF AGREEMENT

This Memorandum of Agreement ("Agreement") is entered into as of March 31, 2012, by and between the Santa Barbara County Sheriff's Office ("County Sheriff"), and, the Santa Barbara County Superior Court ("Court") as described further below.

RECITALS

WHEREAS, the County Sheriff provides bailiff, inmate security, and armed deputies for perimeter security/weapons screening services to the Court; and

WHEREAS, the Budget Act of 2011 (AB 118 and AB 121) realigned the funding for such services from the Court to the County Sheriff with funding for private security guards and related operations expenses of the perimeter security/weapons screening program intended to remain with the Court; and

WHEREAS, an error occurred in the Legislation which resulted in funds being incorrectly allocated to the County Sheriff for the costs of private security contracts with the Court; and

WHEREAS, \$6.7 million was the total amount of funding for FY 2011-12 for both the County-provided security services and the Court-provided private security contract and related expenses; and

WHEREAS, the County Sheriff and the Court mutually agree that the County Sheriff shall transfer to the Court the amount of \$330,711 which is a portion of the amount that should have remained with the Court for FY 2011-12;

NOW THEREFORE, in consideration of the foregoing premises and the mutual promises and covenants as set forth below, the parties agree as follows:

The County Sheriff will transfer to the Court \$330,711 to cover certain FY 2011-12 Court costs of perimeter security/weapons screening paid for by the Court.

In receipt of this funding, the Court will pay for the costs of perimeter security/weapons screening services provided by private security companies.

This agreement does not represent any continuing obligation of the County Sheriff to pay for perimeter security/weapons screening services provided by private security guards under contract to the Court. Neither does this agreement constitute any representation by the Court that the amount being transferred (\$330,711) is the full amount of the FY 2011-12 costs of the Court's private security contract.

In the event of corrective legislation which addresses and corrects this FY 2011-12 funding error, Court shall deduct from the County Sheriff's obligation pursuant to this agreement, any amounts reallocated directly to the Court not to exceed \$330,711.

If any provision in the Agreement is held invalid, the remaining provisions remain in effect. This Agreement may be executed in any number of counterparts, and all such counterparts shall together constitute one and the same instrument. This Agreement constitutes the entire agreement of the parties hereto in conjunction with the matters considered herein, and supersedes any previous agreement or understandings. It may not be modified except in writing executed by both parties.

This agreement expires June 30, 2012.


