

FIRST AMENDMENT TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

This First Amendment to the Agreement for Services of Independent Contractor ("AGREEMENT") between the County of Santa Barbara ("COUNTY") and Stacy Miller Public Affairs, Inc. ("CONTRACTOR"), wherein CONTRACTOR agrees to provide and COUNTY agrees to accept the services specified herein.

WHEREAS, the COUNTY continues to require the special services of CONTRACTOR for interim general County communications support services; and

WHEREAS, Paragraph 25 of the AGREEMENT states the AGREEMENT may be altered, amended or modified by an instrument in writing, executed by the Parties; and

WHEREAS, the COUNTY wishes to extend the term of the AGREEMENT to December 31, 2022 and increase the not-to-exceed contract amount to \$144,000.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

The Parties agree to amend the AGREEMENT as follows:

1. Paragraph 4, Term is revised to state:

CONTRACTOR shall commence performance on April 1, 2022 and end performance upon completion, but no later than December 31, 2022, unless otherwise directed by COUNTY or unless earlier terminated.

2. Paragraph A of Exhibit B, Payment Arrangements Periodic Compensation is revised to state as follows:

For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a one-time fee of \$18,500 for the services identified as flat fee services on Exhibit A and \$14,000 per month for the services identified as ongoing monthly services on Exhibit A for a total contract amount, including cost reimbursements, not to exceed \$144,000

3. In all other respects, the AGREEMENT remains unchanged and in full effect.

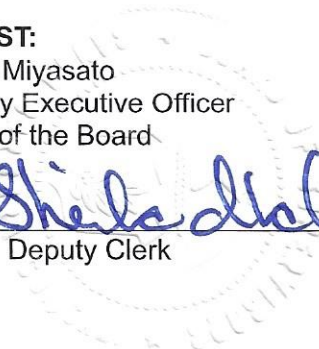
