RESOLUTION NO. 24-282

WHEREAS, the Board of Supervisors (Board) of the County of Santa Barbara (the "County") desires to begin proceedings to form the Santa Barbara County Wine Improvement District ("SBCWID"); and

WHEREAS, the Santa Barbara County Vintners' Association, wine tasting facility owners, and representatives from the County have met to consider the formation of the SBCWID; and

WHEREAS, a portion of the territory proposed to be included in the SBCWID lies within the boundaries of the cities of Carpinteria, Santa Barbara, Goleta, Solvang, Buellton, Lompoc, Santa Maria, and Guadalupe (cities), as shown on the map attached hereto as Exhibit A and incorporated herein by such attachment; and

WHEREAS, the area of the cities and town which lies within the boundaries of the proposed SBCWID will, in the opinion of the Board, benefit from the improvements and activities, and the purpose sought to be accomplished by the work can best be accomplished be a single comprehensive scheme of work.


NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS THAT:

3. The Clerk of the Board is hereby directed to transmit a certified copy of this Resolution to the City Clerk of the cities of Carpinteria, Santa Barbara, Goleta, Solvang, Buellton, Lompoc, Santa Maria, and Guadalupe.
