Project Description: Current County procedure is to decline for consideration general plan amendments and/or rezones in the Draft Santa Ynez Valley Community Plan (hereinafter "SYVCP") boundary unless the project is considered to be a public benefit as determined by the Planning Commission until the Final SYVCP is adopted.

The proposed revision and clarification of County procedure regarding rezones and general plan amendments in the proposed SYVCP boundary would allow projects to be considered for a general plan amendment and/or rezone if it is consistent with the SYVCP and/or deemed by the Planning Commission to be a public benefit.

A project consistent with the SYVCP and/or determined to be a public benefit would require the preparation of an environmental document to analyze the impacts related to land use and/or zoning changes. Initiation of individual preparation of an environmental document and partial processing would be allowed to occur prior to SYVCP adoption. The project would be reviewed under the goals, policies, and development standards outlined in the Draft SYVCP and would be considered and processed pending the adoption of the SYVCP and the certification of the FEIR.
