No increase in funding is associated with the extension of the completion date.

NOW, THEREFORE, the Agreement is amended as follows:

#### Section 1:

Paragraph 11 of said Contract is hereby amended to read as follows:

11. <u>TIME FOR COMMENCEMENT, COMPLETION</u>: The work to be done under this Agreement shall be completed within (351) Three Hundred Fifty One calendar days after execution of this Agreement. As soon as practicable after the Contract has been executed by both the CONTRACTOR and the COUNTY, a Notice to Proceed will be issued by the County Representative stating the starting date of the Contract time. The CONTRACTOR shall begin work within fifteen (15) calendar days after receiving the Notice to Proceed, unless otherwise provided. Attention is directed to the provisions of this Agreement pertaining to Liquidated Damages for failure to complete the work within the allowed time.
