**SUBJECT: Parking Restrictions within the Permit Parking Area Surrounding Righetti High School in the Orcutt Area, 4<sup>th</sup> Supervisorial District**

**Recommended Actions:**

That the Board of Supervisors adopt a Resolution rescinding the permit parking area and one-hour parking zone that is in effect Monday through Friday, excluding holidays, from eight (8:00) a.m. to five (5:00) p.m. on Fernview Street, Hibiscus Court and Lockford Street in the Orcutt area, 4<sup>th</sup> Supervisorial District.

**Summary Text:**

A petition was received from the residents of Fernview Street, Hibiscus Court and Lockford Street indicating very little support for the existing Permit Parking Program. The residents originally wanted to be included in the Permit Parking Program because they were concerned that student parking would eventually spill over onto their streets with the implementation of permit parking closer to Righetti High School. Currently these residents feel that this is not the case if the Permit Parking Program is removed from their streets.

Based upon the submitted petition, Fernview Street, Hibiscus Court and Lockford Street no longer meet the required criteria of two-thirds support of residents for the Permit Parking Program. The Public Works Department recommends that Fernview Street, Hibiscus Court and Lockford Street be removed from the Permit Parking Program. These streets will not be allowed back into the Permit Parking Program for a minimum of two years. The Department has prepared the attached Resolution rescinding the permit parking area and one-hour parking zone that is in effect Monday through Friday, excluding holidays, from 8:00 AM to 5:00 PM at the following locations:

**RESCIND**

Permit Parking Zones

- On Fernview Street along both sides from the centerline of Brookside Avenue to the centerline of Millstone Avenue.
- On Hibiscus Court along both sides from the southerly terminus to the centerline of Parkland Drive.
- On Lockford Street along both sides from the centerline of Millstone Avenue to the centerline of Foster Road

**Background:**

Sections 22507 and 22507.5 of the California Vehicle Code (CVC) allows local jurisdictions the authority to designate certain streets upon which preferential parking privileges are given to residents and merchants adjacent to the streets for their use and the use of their guests. Pursuant to the CVC, Chapter 23B of the Santa Barbara County Code known as the Permit Parking Program was established in 1994 and amended in 2004 and 2008. The purpose of this chapter was to protect and promote the integrity of resident and guest parking in neighborhoods where there is a serious problem of long term parking by nonresidents.

In 2002 the residents of the neighborhood surrounding Righetti High School wanted a Permit Parking Program established because of the lack of parking and nuisance caused by high school students that would park on the street in front of their houses. In order to approve permit parking, the County determined that it would require two-thirds support of residents from each street or block that wanted the program. A petition was submitted for many streets in the surrounding neighborhood and that same year Resolution 04-317 was adopted establishing a permit parking area and one-hour parking zones in effect Monday through Friday, excluding holidays, from eight (8:00) a.m. to five (5:00) p.m. on several streets surrounding Righetti High School including Fernview Street, Hibiscus Court and Lockford Street.
