

AMENDMENT NO. 2
to the
MEMORANDUM OF UNDERSTANDING
between
Santa Barbara County Association of Governments,
and the
County of Santa Barbara
for the
Sheffield Drive to Ortega Hill Pedestrian and Bicycle Connector

This Amendment No. 2 to the Memorandum of Understanding (MOU) executed on October 19, 2023 between the Santa Barbara County Association of Governments (hereafter "SBCAG"), and the County of Santa Barbara (hereafter "COUNTY"), is hereby amended ("Amendment No. 2") as follows:

1. Section 6, "Funding and Invoicing", subsection "B" is deleted and replaced in its entirety as follows:
 - B. SBCAG will contribute \$420,000 in Regional Surface Transportation Program (RSTP) funding for the Project Approval and Environmental Document (PA&ED), Plans, Specifications, and Estimates (PS&E), and Right of Way (RW) phases.
2. Exhibit D, "PROJECT Funding" is deleted and replaced in its entirety as follows:

PARTIES, in accordance with the provisions of this MOU, hereby agree that the funding table below represents the funding provided for the WORK, as defined in Section 5. COUNTY is responsible for completion of WORK in accordance with Exhibit C.

3. **Counterparts.** This Amendment No. 2 may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
4. **Ratifications.** The terms and provisions set forth in this Amendment No. 2 shall modify and supersede all inconsistent terms and provisions set forth in the MOU and Amendment No. 1. The terms and provisions of the MOU and Amendment No. 1 except as expressly modified and superseded by this Amendment No. 2, are ratified and confirmed and shall continue in full force and effect, and shall continue to be legal, valid, binding and enforceable obligations of the parties.
