Recommendation(s):

That the Board of Directors:

A. Accept the Notice of Completion for work performed by the contractor, US Energy Services, Inc. (not a local vendor), 8245 East Bell Road, Suite 132, Scottsdale, AZ 85260, and authorize the Clerk of the Board to record.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 1, An Efficient Government Able to Respond Effectively to the Needs of the Community, and Goal No. 2, A Safe and Healthy Community in Which to Live, Work, and Visit.

Executive Summary and Discussion:

The project consisted of the design and installation of five micro turbines at the Laguna County Sanitation District wastewater reclamation plant in order to help offset overall power consumption. Three micro turbines are fueled by natural gas, which in turn generate heat for the digester. The digester produces methane, which is used for fueling the two methane burning micro turbines. The micro turbines will save significant power costs and in approximately five years allow the District to recoup its investment costs. The project was approved by the debt advisory committee (DAC) on November 5, 2003 and was funded by a certificate of participation (COP) approved by the Board on December 9, 2003 and a California Public Utilities Commission (CPUC) rebate distributed through the Pacific Gas & Electric Company (PG&E), which was received on Tuesday, May 31, 2005. The design and installation agreements (BC 04-171 and BC

04-172 respectively) with US Energy Services, Inc. were executed by the Board on March 23, 2004. Upon design completion, construction was initiated in October 2004 and the system began operation in February 2005. A performance guarantee defined in the design contract defines how performance and cost savings are to be measured over the five year period beginning at initial operation. This action releases the performance bond required per the terms and conditions of the installation agreement.

Mandates and Service Levels:

There are no changes with programs or service levels with this action.

Fiscal and Facilities Impacts:

The project was funded by a certificate of participation (COP) approved by the Board on December 9, 2003 in the amount of \$795,696.00 and California Public Utilities Commission (CPUC) rebates in the amount of \$270,000 distributed through the Pacific Gas & Electric Company (PG&E) for a total funding amount of \$1,065,696.00. Final implementation costs were \$998,929.60 (Amendment No. 1 to the construction contract approved by the Board on February 8, 2005 had a net reduction of \$66,766.40). Annual debt service on the five year COP is \$171,230 based on a 2.7% interest rate. The vendor has indicated that the project is expected to provide a net savings of approximately \$188,302.00 annually.
