Authorize the Chair to execute Amendment No. 1, for a two year time extension to the existing agreement with Quincy Engineering Incorporated (QEI) for Detailed Design and Construction support for the Tepusquet Low-water Crossing Replacement, Project No.862248

Summary Text:

The Tepusquet Low-water Crossing Replacement project provides for the construction of a new bridge and approach roads over the Sisquoc River near the town of Sisquoc. The existing Low-water Crossing provides unreliable access to the traveling public and impedes emergency service vehicles during the winter months. The new bridge will provide a safe, all weather crossing for the community.

QEI, was selected to complete Detailed Design and Construction Support for this project. The termination date of the current contract is June 30, 2008, which only provides enough time to complete Detailed Design. Therefore, staff is requesting a two year time extension to complete the remaining tasks required for this project.

Background: In accordance with Federal and State requirements the County released a Request for Proposals to sixteen qualified firms on September 30, 2005. An evaluation committee from the County Public Works Department evaluated the three proposals submitted based on a predetermined evaluation criterion. Following the evaluation and scoring the committee ranked QEI as the most qualified firm and recommended that this firm be selected to perform Preliminary Design and Environmental Services for this project. On January 10, 2006 your Board approved a contract for Preliminary Design and Environmental Services with QEI. At that time staff reported that upon satisfactory completion of Phase I services by QEI, we would negotiate with QEI for Phase II which we completed in May 2007. On June 26, 2007, the Board of Supervisor approved an agreement with Quincy Engineering Inc., for Detailed Design and Construction Support for the replacement of the Tepusquet Low-water Crossing replacement.
