Based on a preliminary review of the project the following activity is determined to be exempt from further environmental review requirements of the California Environmental Quality Act (CEQA) of 1970, as defined in the State and County Guidelines for the implementation of CEQA.

PROJECT TITLE: Statement of Final Quantities for the 2010-11 Gallegly SAFETEA-LU Hot Mix Asphalt Overlay in the Third, Fourth, and Fifth Supervisorial Districts.

PROJECT DESCRIPTION: Request for the Chair of the Board of Supervisors to execute the Statement of Final Quantities for the FY 2010/2011 Gallegly SAFETEA-LU Hot Mix Asphalt Overlay in the Third, Fourth, and Fifth Supervisorial Districts for work performed and materials supplied by Granite Construction Company in the amount of \$3,019,099.50. Construction consisted of repairing failed pavement areas and placing Type A asphalt concrete over a Stress Absorbing Membrane Interlayer (SAMI), and an asphalt concrete leveling course. A total of 16.7 lane miles of roadway were resurfaced,

Further, the Statement of Final Quantities will not create any unusual circumstances which would create a possibility that there would be a significant effect.
