Dear Chair Farr, Vice Chair Carbajal and Supervisors:

Following submittal of our legal letter on February 28, 2013, Verizon Wireless received 287 text messages and 44 emails supporting the proposed facility in Montecito. A letter from Verizon Wireless Marketing Director Ross Bennett dated March 8, 2013 evidencing the 287 support text messages received last week is attached to this letter. Also attached are 44 support emails received last week for your review. In total, since August, over 500 residents have sent text messages and emails of support. These emails and text messages evidence the need of residents to maintain reliable Verizon Wireless service in Montecito. Indeed, the emails confirm that reliable cell phone service can save lives, particularly when it is a resident's only means to receive the County's reverse E911 crisis calls.¹ Hard copies of these materials will be available at your Board meeting tomorrow.
