Recommended Actions:

1. Approve and execute a three-year Support and Maintenance Agreement with Echo Consulting Services of California, Inc. (not a local vendor) for the County's behavioral health information management system for a maximum contract in the amount of \$509,878, inclusive of annual fees in the amount \$120,000 for Fiscal Year 12-13, \$140,000 for Fiscal Year 13-14, \$144,878 for Fiscal Year 14-15; and a contingency amount to be used only in the event of State-mandated upgrades in the maximum amount of \$35,000 per fiscal year.

Summary Text:

In August 2009, the Board of Supervisors approved a three-year contract with Echo Consulting Services of California, Inc. for Support and Maintenance services for Alcohol, Drug and Mental Health Services' (ADMHS) behavioral health information software system. The recommended action will continue the Support and Maintenance Agreement (SMA) for a subsequent three-year period to provide all necessary technical support services for the ShareCare system through FY 14-15. The contract also includes a contingency maximum of \$35,000 per fiscal year to cover Santa Barbara's portion of potential development costs in the event of changes required by State mandates.

Background:

The SMA covers technical support of the ShareCare product as well as the interfaces with existing ADMHS systems and other ancillary software applications. Clinical services are recorded through

ADMHS' clinical management application, Clinician's Gateway, and an interface between ShareCare and Clinician's Gateway facilitates the regular exchange of data between the applications.

Although ADMHS experienced implementation issues with the product, the system is in operation and has been successfully uploading claims for reimbursement to Medi-Cal and Medicare as of January 2008. An extension to the existing three-year SMA is recommended because it enables ADMHS to lock in a specific price for the multi-year period. The SMA includes penalties that can be applied in the event of the vendor's failure to comply with required mandates or when errors result in delays in claiming for reimbursement. The SMA provides that the software will comply with all Federal and California State reporting and funding requirements including Medi-Cal, Medicare, Mental Health Services Act (MHSA), Drug Medi-Cal, California Outcomes Measurement System (CalOMS), and Client and Services Information (CSI).

Over the last several years, the State of California Department of Mental Health has made numerous changes to their information technology systems, most recently Short-Doyle Phase II and 5010 upgrades. Each time, software vendors go through an extensive development and testing phase to meet the new requirements. Because additional changes are likely between 2012 and 2015, ADMHS has negotiated an annual maximum for Santa Barbara's portion, of \$35,000 per fiscal year, which is included in this contract maximum amount. This amount will only be utilized in the event of a Statemandated update to the system.

Approval of the recommended action allows for support and maintenance of ADMHS' behavioral health information software system.

Approval of the recommended action will assist ADMHS in meeting the following measures:

- \Box To ensure that departmental funding sources are uninterrupted, submit the Mental Health Medi-Cal claim by the 30^{th} of the target month.
- \Box To ensure that departmental funding sources are uninterrupted, submit the Drug Medi-Cal claim by the 30th of the target month.
- \Box To ensure that departmental funding sources are uninterrupted, submit the Mental Health Medicare claim by the 30^{th} of the target month.
