

RESOLUTION – 22-203
AUTHORIZING THE APPLICATION FOR GRANT FUNDING
UNDER THE REGIONAL CLIMATE COLLABORATIVE PROGRAM
AS ADMINISTERED BY THE STRATEGIC GROWTH COUNCIL

WHEREAS, in 2021 the Legislature and the Governor of the State of California provided funds for the Regional Climate Collaborative grant program, pursuant to SB 1072 (2018); and

WHEREAS, the Strategic Growth Council is responsible for the administration of this Regional Climate Collaborative grant program, including developing guidelines and selection criteria; and

WHEREAS, the Strategic Growth Council released the application guidance on April 28, 2022, with an application due date of October 7, 2022; and

WHEREAS, procedures established by the Strategic Growth Council require this Resolution by the County of Santa Barbara Board of Supervisors certifying the approval of the application submitted by the County for the Regional Climate Collaborative grant; and

WHEREAS, the County of Santa Barbara Community Services Department is authorized to apply for and accept a Regional Climate Collaborative grant if awarded; now, therefore, be it

RESOLVED that the County of Santa Barbara Board of Supervisors approves the submittal of an application for a Regional Climate Collaborative grant for funding from fiscal year 2022-23 through 2025-26, to be submitted no later than October 7, 2022.

FURTHER RESOLVED that the County certifies that, in partnership with its co-applicants, it will have sufficient resources to execute the capacity building activities that are outlined in the grant application.

FURTHER RESOLVED that the County authorizes the Director of the Community Services Department, or designee, to conduct all negotiations and execute the grant agreement and payment requests that may be necessary for completion of the aforementioned capacity building activities.

FURTHER RESOLVED that the County Clerk shall certify the adoption of this Resolution, which shall take effect immediately upon adoption.
