The Santa Barbara County Woman's Commission intends to use its 50-year long connections and reputation to re-ignite its award-winning Women Speak Up Town Hall Events to be back in-person and enhance the distribution of those events via social media and local PSA spots on tv stations. We intend to have at least four in-person town halls across the county to address women's veteran needs and promote women on boards and commissions; to collect this information, we will be using grant funding to develop surveys to be used via survey monkey, print, and distribute bilingual surveys to in-person events and community partner locations. We will be developing a brochure and other promotional materials and PSA's for the commission to enhance its recognition and influence across the county.

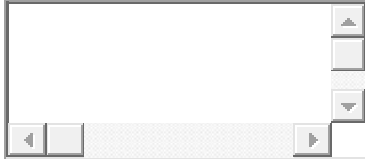
The Santa Barbara County Woman's Commission intends to use its 50-year long connections and reputation to re-ignite its award-winning Women Speak Up Town Hall Events to be back in-person and enhance the distribution of those events via social media and local tv stations. We hope to have at least four Town Halls across the county addressing our priorities regarding women veterans and promoting of women in government and boards. The Commission has been involved with our local Veterans Stand Down from its inception in 2012. We are aware that

women veterans can face unique needs and additional stress regarding issues such as childcare, employment, homelessness, domestic violence, sexual assault, sexual identity, and access to continuing mental health services. Addressing these unique needs are a priority for the commission and we plan on developing, collecting, and evaluating surveys of veterans at town halls across the county as well as working with our local veteran's clinic, Vandenberg Space Force, and various veteran-specific non-profits such as WEBS and Band of Brothers. These surveys can be collected via survey monkey or collected in person at events and locations that serve veterans. We will then use that information to lobby for resources to be available at our local Veterans Stand Down Events as well as to lobby our Local, State and Congressional Representatives for legal changes or development of additional funding streams for services, if needed. Elevating women's voices through involvement on boards and commissions is a priority especially after Covid and what is considered the 'Great Resignation' which has been very detrimental to women. The Commission continually requests studies on DEI (diversity, equity, and inclusion) in our county. We currently have extensive information regarding Santa Barbara's south county, and we need to possibly fund and research the data for the north county as well. We intend to work with our local city governments and organizations to host our Women Speak Up town halls and events to help recruit and encourage women to become involved in our local boards, organizations, and commissions. Recruiting more diversity and promoting more inclusion will help bring more young women as active participants in our local politics and community leadership. These efforts will help to improve the daily life experiences for all members of our communities. We also believe that the involvement of women on the local library board or on the parks and rec commission can greatly improve the lives of women and children in our communities by expanding opportunities and understanding of how these vital government entities function. The Commission also intends to expand our visibility and profile with the development of brochures and PSA's developed with our local tv stations. This professional production element does incur necessary expenses well beyond our normal operating experiences. In addition, we are including updates and other improvements to our social media platform as well as on our website

What major impact will the budget reduction have on your proposed impact? *

Your answer The Commission is dedicated to our priorities. The identified programs and outreach regarding town halls, veterans' services, and the pursuit of DEI on all Boards and Commissions will continue. However, this work will be greatly diminished in its scope for the coming year without this funding. We will only be able to afford perhaps only one in-person town hall event, and the development, distribution, and evaluation of our survey materials for vets will be likely spread out over a few years. With this funding, we will be able to develop crucial outreach materials and improve our social media presence, as well as produce professional Public Service Announcement (PSA) videos for effective county-wide distribution. This is vital to enhancing our ability to influence and lobby for needed changes and opportunities designed to improve the lives of women and girls within our community.



To that end we will be making contacts within our diverse racial, LGBTQ+, religious, ableism, and class-based groups to ensure that we our concepts and practices are culturally competent and therefore beneficial for all segments of our community. We plan to develop and target our PSA's for future distribution ahead of our new and improved Women Speak Up events. We will be confirming our logistics including contracting locations, organizing, and advertising for our future Town Halls that would eventually cover the geographically wide areas that are referred to as north, south, and mid county.
