CERTIFICATE OF FACTS BY COUNTY CLERK-RECORDER-ASSESSOR REGARDING APPOINTMENT IN LIEU PROCEDURES FOR SPECIAL DISTRICT OFFICES

I, Joseph E. Holland, County Clerk-Recorder-Assessor, County of Santa Barbara, DO
HEREBY CERTIFY THE FOLLOWING FACTS:

By 5 p.m. on the 83rd day prior to the day fixed for the general district election:

- (a) no one filed a declaration of candidacy for such office, and
- (b) a petition requesting that the election be held was not presented to this office.

Therefore, per Elections Code Section 10515 (b) I hereby request that the Board of Supervisors, as the supervising authority, appoint any person or persons to the office who is/are qualified on the date when the election would have been held, November 8, 2016. The person(s) appointed shall qualify and take office and serve exactly as if elected at a general district election for the office.

Special Considerations for Casmalia Community Services District:

The Casmalia Community Services District has a five (5) member board, and needs four (4) appointments to be made. The one seated member's term expires in 2018. A minimum of two (2) appointments are required for this district to have a quorum.

Special Considerations for Cuyama Valley Recreation District:

The Cuyama Valley Recreation District has a five (5) member board, and needs three (3) appointments to be made. The remaining two seated member's term expires in 2018. A minimum of one (1) appointment is required for this district to have a quorum.
