On February 4, 2025, the County Board of Supervisors will conduct a public hearing to consider a package of various proposed ordinance amendments: (1) adopting a Senate Bill (SB) 9 Ordinance in compliance with State law, (2) revisions to the existing Commercial Telecommunication Facilities Ordinance, (3) processing other Minor Amendments to update the allowed uses in the Limited Commercial (C-1) and General Industry (M-2) zones districts, and (4) revisions to the existing Accessory Dwelling Unit (ADU) and Junior Accessory Dwelling Unit (JADU) Ordinance to comply with recent State legislation, consisting of the following:

- Add provisions and development standards to the County Zoning Codes and Chapter 21, Land Division, in accordance with SB 9 regulations (Government Code Sections 65852 21 and 66411.7);

  Revise existing development standards and permit procedures for Commercial Telecommunication Facilities to align with the Federal Communication Commission's 2018 Small Cell Order.

  Process other minor ordinance amendments to update existing text provisions, including updating allowed uses in the C-1 zone district in Article II, Coastal Zoning Ordinance (CZO), General Industry M-2 zone district in the County Land Use and Development Code (L/IDC), and implementing clarifications and necessary revisions to the existing ADU/JADU Ordinance to align with changes to State law; and

  A resolution to request the Board of Supervisors direct staff to submit the Article II, CZO Amendments to the California Coastal Commission for review and certification.
