

Resolution of the Board of Supervisors of the County of Santa Barbara, State of California

IN THE MATTER OF AUTHORIZING THE DISTRICT)
ATTORNEY TO CONTRACT WITH THE)
CALIFORNIA VICTIM COMPENSATION BOARD)

RESOLUTION NO: 26-138

WHEREAS, Government Code sections 13950 et seq. authorizes the California Victim Compensation Board to provide compensation to victims of crime for the financial losses they experience as victims of crime; and

WHEREAS, the Board of Supervisors has designated the District Attorney's Victim Witness Program as a Victim Center and provider of major and comprehensive victim and witness services in the County of Santa Barbara; and

WHEREAS, the District Attorney's Office has the desire and capability to continue providing claim verification and eligibility determination; and

WHEREAS, the California Victim Compensation Board is authorized to contract with local Victim Centers to provide claim verification and eligibility determination for expedited payments of funeral burial expenses, crime scene clean-up, and emergency domestic violence and sexual assault relocation expenses, and to make \$65,000 available annually for this purpose over the three-year Agreement.

IT IS HEREBY RESOLVED that the County of Santa Barbara Board of Supervisors authorizes the District Attorney or designee to renew the Agreement with the California Victim Compensation Board to provide expedient financial assistance to victims of crime and their families for the period of July 1, 2026 through June 30, 2029 (Agreement No. S26-036) and acknowledges the terms and conditions contained therein.

BE IT FURTHER RESOLVED that the County of Santa Barbara Board of Supervisors authorizes the District Attorney or designee to execute amendments to the Standard Agreement extending the term thereof through December 30, 2029, or for a supplemental grant award in the amount not to exceed \$25,000 annually.

BE IT FURTHER RESOLVED that the State funds received hereunder shall only be disbursed with strict adherence to State guidelines and regulations.

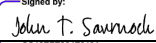

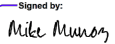

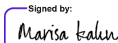
