Re: Resolution of the Board of Supervisors of the County of Santa Barbara Opposing New Offshore Oil Leases in Federal Waters

To Whom It May Concern:

Santa Barbara County has witnessed firsthand the devastating consequences of offshore oil drilling—both environmental and economic. In 1969, a catastrophic blowout spilled over 3 million gallons of crude oil into the Santa Barbara Channel, killing thousands of marine animals and polluting miles of pristine coastline. That event catalyzed the modern environmental movement and reshaped the national conversation about energy development and ocean stewardship.

More recently, in 2015, a pipeline rupture at Refugio State Beach released over 120,000 gallons of oil, 53,000 gallons of which reached the ocean, again fouling our waters, damaging local fisheries, and inflicting deep harm on marine ecosystems and coastal tourism. The consequences of these incidents continue to reverberate through our community.

Now, as the federal government considers new offshore oil and gas leasing through the 2025–2030 National Outer Continental Shelf (OCS) Leasing Program, Santa Barbara County reaffirms its strong opposition. New offshore oil drilling is incompatible with our region's economic vitality, environmental health, and climate goals. The Central Coast is home to national marine sanctuaries, endangered species, and a thriving ocean-based economy centered around recreation, clean energy, and tourism. In Santa Barbara County alone, these sectors generate millions in revenue and support thousands of local jobs.

We join with a broad coalition of local governments, state leaders, scientists, and residents in urging the Department of the Interior and the Bureau of Ocean Energy Management (BOEM) to exclude all areas offshore California from future lease sales.

Our coastline is a national treasure. It deserves permanent protection—not renewed threats.
