#### **Summary Text:**

On June 27, 2006, the Board of Supervisors executed a Professional Services Agreement for the Preparation of the Goleta Beach Long Term Protection Plan Environmental Impact Report (EIR) with Chambers Group, Inc. The existing contract requires that work be completed no later than June 1, 2007. Due to the time required to adequately address public comments submitted during the draft EIR public comment period and to assist County Parks with the EIR through completion, this amendment revises the term of the contract to December 31, 2007.

**Background:** On June 27, 2006, the Board of Supervisors executed a Professional Services Agreement for the Preparation of the Goleta Beach Long Term Protection Plan Environmental Impact Report (EIR) with Chambers Group, Inc. The draft EIR has been circulated for public comment with the public comment period expiring May 14, 2007.

The existing agreement with Chambers Group, Inc. requires that work be completed no later than June 1, 2007. Due to the time required to adequately address public comments submitted during the draft
