Recommended Actions:

That the Board of Supervisors:

- A. Approve plans and specifications for Construction of 2010-11 Proposition 1B Hot Mix Asphalt Overlay in the First, Second, and Third Supervisorial Districts of Santa Barbara County; County Project No. 810538;
- B. Award the construction contract in the amount of \$1,217,938.42 to the lowest responsible bidder, Granite Construction Company (a Local Vendor with an office in Goleta), P.O. Box 50085, Watsonville, Ca 95077-50085 subject to the provision of documents and certifications, as set forth in the plans and specifications applicable to the project, as required under California Law;
- C. Authorize the Chair to execute the construction contract, upon return of the Contractor's executed contract documents, and the review and approval of the County Counsel, Auditor-Controller and Risk Manager or their authorized representatives; and
- D. Approve contingency funds in the amount of \$73,396.92 for Construction of 2010-11 Proposition 1B Hot Mix Asphalt Overlay in the First, Second, and Third Supervisorial Districts of Santa Barbara County; County Project No. 810538.

Summary Text:

On Thursday, January 20, 2011, two (2) bids were opened for Construction of 2010-11 Proposition 1B Hot Mix Asphalt Overlay in the First, Second, and Third Supervisorial Districts of Santa Barbara County; County Project No. 810538. Granite Construction Company, Inc., a California Corporation submitted the lowest responsible bid in the amount of \$1,217,938.42, which is 0.7 % above the Engineer’s Estimate. Because the low bid was within the budgeted amount for the base project *plus* the additive items as described on Attachment A, both the base project and the additive work are recommended for award.

The Department has performed an analysis of the bids received and has determined that the low bid is responsive and reasonable. Staff recommends awarding this contract to Granite Construction Company, Inc.

This project will rehabilitate and resurface sections of Channel Drive, San Ysidro Road, Patterson Avenue, El Colegio, and Camino Corto.

Approximately 4.58 lane miles of County maintained roads will be resurfaced with the construction of this project. This project was bid in accordance with the Public Contract Code, which requires the award to the lowest responsible bidder.

Background:

Proposition 1B Local Streets and Roads (Prop 1B-LSR) funds are dedicated to transportation infrastructure rehabilitation, repair and improvement. These State bond funds were originally intended to be paid over a five-year period and then eliminated. As part of recent State budget work, the State paid out the entire remaining 3 years of Prop 1B-LSR funds this year to fund projects over the next three years. The expenditure plan for these funds, including this project, was approved by your Board on June 1, 2010. The Department has a north County pavement rehabilitation project using Prop 1B-LSR funds planned for summer 2011 construction.
