America Celebrates the 3rd Annual Probation, Parole & Community Supervision Officers' Week July 14-20, 2002

During the week of July 14-20, 2002, probation, parole, community supervision officers, criminal and juvenile justice professionals and communities will join together across America to celebrate the 3rd annual Probation, Parole & Community Supervision Officers' Week.

Over 80,000 of these dedicated public servants work one on one with criminal offenders on a daily basis. They are literally on the front lines working for public safety for our communities. These officers supervise over 4.5 million adult men and women who are on probation and parole. Over 600,000 juvenile offenders are under community supervision. These officers work diligently, with limited resources, to ensure public safety, provide victims services, and hold offenders accountable. Public safety is their first and foremost concern.

These are the people who restore our hope and our safety by providing a balance of prevention, intervention and advocacy. They deliver accountable, humane, effective, and individualized services for offenders, and support, protection, and reparation for victims and the community. It is through the actions and dedication of these officers that APPA's vision of community justice and safety for all comes closer to being realized.

Recognize and support these officers during Probation, Parole and Community Supervision Officers' Week, July 14-20, 2002. These are the unsung heroes who have languished in the shadows far too long. Recognize and honor these officers who go beyond the call of duty to make a difference in the lives of those in your community.

**RESOLUTION PROCLAIMING
JULY 14-20, 2002 AS “PROBATION,
PAROLE, AND COMMUNITY
SUPERVISION OFFICERS’ WEEK”**

WHEREAS, Probation Officers provide essential services to the communities of Santa Barbara County by protecting and enhancing the public trust through enforcing court orders, providing information and sentencing recommendations to the Courts, providing services to and helping repair the harm done to victims and the community by criminal offenders, by holding adult and juvenile offenders accountable for their behavior and assisting them in reforming their lives; and

WHEREAS, Juvenile Institutions Officers provide essential services to the communities of Santa Barbara County by providing safe and secure juvenile detention and treatment facilities, and by counseling, guiding, and instilling responsibility and accountability in minors in our care and custody; by insuring restorative justice to the community through the Weekend Work Project and Community Work Crews; and

WHEREAS, Probation and Juvenile Institutions Officers provide an efficient and cost effective use of public resources by supervising over 4.5 million adult and 600,000 juvenile offenders nationally, and within Santa Barbara County locally supervising over 6,000 adult and 1,200 juvenile offenders at any given time, and for over 90 years, Santa Barbara County Probation and Juvenile Institutions Officers have dedicated their lives to help make safer communities for us all; and

WHEREAS, Probation and Juvenile Institutions Officers work hand in hand with police officers, alcohol, drug, and mental health workers, community groups, and social service agencies in partnerships and collaboratives which efficiently utilize public resources in protecting the public through offender accountability and by providing victims of crime and adult and juvenile offenders the support they need; and

NOW, THEREFORE, BE IT RESOLVED AND HEREBY ORDERED that the Board of Supervisors of the County of Santa Barbara, State of California, proclaims the week of July 14 through July 20, 2002 as “Probation, Parole, and Community Supervision Officers’ Week” and joins in recognizing these men and women whose professionalism and dedication to their work contribute significantly to making Santa Barbara County a safer place to live.
