



Owner's Statement



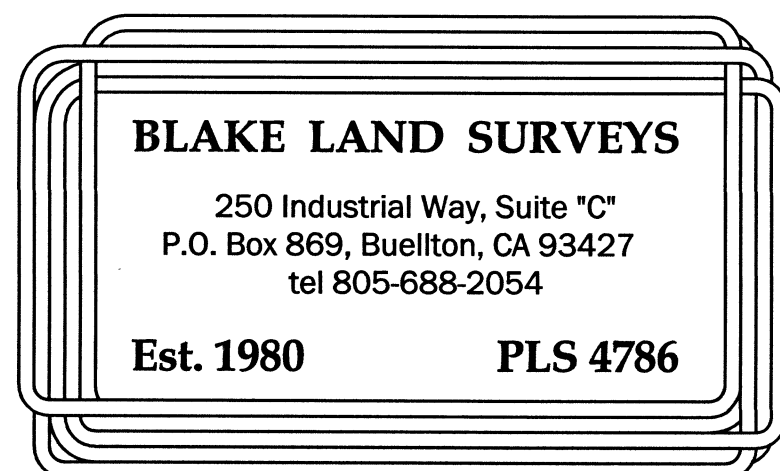

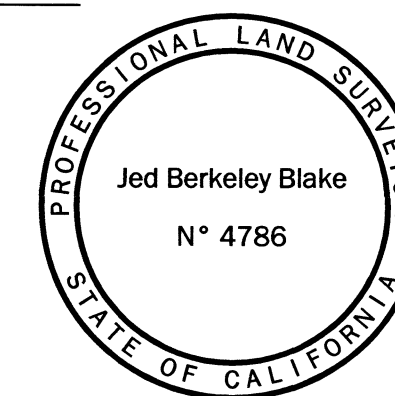


Surveyor's Statement
