

**THIRD AMENDMENT TO AGREEMENT FOR SERVICES
OF INDEPENDENT CONTRACTOR BETWEEN
THE COUNTY OF SANTA BARBARA AND
CLEAN HARBORS ENVIRONMENTAL SERVICES, INC.**

This **AMENDMENT** to the **AGREEMENT** is entered into by and between the:

COUNTY OF SANTA BARBARA, CALIFORNIA, hereinafter referred to as
“**COUNTY**”, and

CLEAN HARBORS ENVIRONMENTAL SERVICES, INC., hereinafter referred to
as “**CONTRACTOR**”,

WHEREAS, **COUNTY** and **CONTRACTOR** have an existing **AGREEMENT** dated
June 19, 2012 for the transportation, management, recycling and disposal of hazardous waste
collected through County solid waste collection programs.

NOW, THEREFORE, IT IS AGREED as follows:

1. The **AGREEMENT** is amended to replace the **THIRD PARAGRAPH** in
SECTION A.1, EXHIBIT A, AMENDED STATEMENT OF WORK
as follows:

The Contractor will be required to service the CHWCC every Monday,
arriving between 11:00 a.m. and 2:00 p.m., or in a reasonable amount
of time necessary to complete work by close of day, due to facility
storage constraints
2. The **AGREEMENT** is amended to replace **Paragraph A** of **EXHIBIT B,
PAYMENT ARRANGEMENTS** as follows:
 - A. This Amendment to the contract shall increase the contract amount
by \$1,164,036 (\$557,636 for year four and \$606,400 for year five)
and shall extend the contract for an additional two (2) years for a
total of a five (5) year Agreement in a not-to-exceed amount of
\$2,709,154.
3. The **AGREEMENT** is amended to replace **ATTACHMENT A1, COST
FOR SERVICES** in its entirety.
4. Except as provided herein, the parties have executed this **AMENDMENT**
to be effective on the date executed by **COUNTY**.

IN WITNESS WHEREOF, the parties have executed this Third Amendment to Agreement to be effective on the date executed by COUNTY.
