The Very Reverend Father Jon-Stephen Hedges, Assistant Pastor at St. Athanasius Church in Isla Vista, was a well regarded community spiritual leader. He served as chaplain with the County Sheriff's Department, Isla Vista Foot Patrol; worked with a number of community service agencies such as Doctor's Without Walls, American Red Cross and County Departments (CSD, Probation, Public Defender, DSS, BeWell, etc.) among others. Trained as a board-certified crisis chaplain with the American Academy of Experts in Traumatic Stress; Certified Trauma Responder (CTR) and Emergency Medical Technician EMT-B), his training and experience made him uniquely qualified to meet the needs of, and actively advocate for, the unhoused residents in his community. He helped develop the St. Brigid Fellowship, which serves unsheltered community residents, and supported the County Isla Vista Temporary Emergency Shelter and Navigation Center at the Isla Vista Community Center and IV Recreation and Park District site. He also supported the development of a permanent 'South County Navigation Center', which makes the naming of the current County property as "Hedges House of Hope" a fitting memorial to a brave and dedicated public servant.
