Recommended Actions:

That the Board of Supervisors:

Accept the 2009 Fiscal Issues Report and receive a presentation on the economic context and impending financial challenges faced by the County in FY 2009-10 and in the immediate horizon.

Summary Text:

The Fiscal Issues Report provides the Board of Supervisor a report entitled "Fiscal Issues Report." The Fiscal Issues Report provides the Board a summary of the key financial issues that comprise the context for the County's financial status. The report discusses the County's economic picture and key financial issues that will or are likely to impact the County's budget. The timing of this report is to provide the Board the opportunity to review these issues prior to taking action on the State Budget Impacts, originally presented to the Board on August 18, 2009, and scheduled for further hearing on October 13, 2009, and prior to adopting Budget Development Principles and commencing the development process for the FY 2010-11 budget. This report was first introduced in 2007 and has been updated yearly. In addition, the County Executive Office has been providing the Board with monthly updates of the significant fiscal issues throughout the past year. Moving forward, the County Executive Office intends to provide these updates quarterly along with the quarterly financial reports in order to focus on the significant fiscal issues at a consolidated hearing.
