Recommendation(s):

That the Board of Supervisors:

- A. Approve the Project and Categorical Exemption pursuant to the County's California Environmental Quality Act (CEQA) guidelines for the construction of Storm Damage Repairs on Kinevan Road at three locations, Project No. 01STRM, R016;
- B. Authorize the Director of Public Works to advertise for construction bids for Storm Damage Repairs on Kinevan Road at three locations, Project No. 01STRM, R016.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 1. An Efficient Government Able to Anticipate and Respond Effectively to the needs of the Community.

Executive Summary and Discussion:

The storms of March 2001 resulted in high flows in San Jose Creek that eroded portions of the stream bank and damaged retaining walls and bridge wingwalls at 3 locations on Kinevan Road.



Stream bank erosion occurred at Bridge 51C-214, Bridge 51C-215 and at MP 0.32 causing damage to a sandstone block wingwall at Bridge 51C-214, a concrete wingwall at Bridge 51C-215, and a retaining wall at MP 0.32.

The damaged portion of the sandstone wingwall at Bridge 51C-214 will be replaced with grouted rock riprap.

The project will repair the eroded creek banks at Bridge 51C-215 by placing new rock riprap and concrete slurry.

The undermined retaining wall at MP 0.32 will be supported by a concrete cut-off wall and the damaged sacked concrete slope protection will be replaced by a concrete retaining wall and rock gabions.



Pursuant to the County's CEQA guidelines, the project has been determined to be exempt from further environmental review. Approval of this Notice of Exemption shall indicate the Board of Supervisors' approval of this project and will commence the appeal period, pursuant to CEQA guidelines.

The "Notice to Contractors" will be published prior to the date set for the opening of bids.

Sealed proposals will be received at the Public Works front counter in the County Engineering Building, 123 E. Anapamu Street, Santa Barbara, California 93101, and at the North County Public Works office, 2400 Professional Parkway, Suite 150, Santa Maria, California, and will be opened and publicly read aloud at a date to be determined.

The project was approved as part of the FY 02/03 Capital Improvement Plan.
