ATTACHMENT 1 TO CLAIM

Kimberly Cantin ("Kim") is the sole surviving parent of John Michael Cantin ("Jack"). Jack was killed during the Montecito Mudslide/Debris Flow on January 9, 2018. His body was never recovered. Kim is the statutorily designated person to receive and dispose of Jack's remains.

Between May - July 2021, a UCSB Anthropology Department team found human remains and concluded to a 90% certainty that they were Jack's remains. Sheriff-Coroner William Brown ("Sheriff") rejected that report, and returned the two bones to Kim that had been tested by his alleged expert.

Kim subsequently loaned the Sheriff one more of the rest of the remains, a shin bone, to be tested for DNA. This loan was based on the Sheriff's agreement to only take one of the bones for testing, and to return the remnants of that bone to Kim. After DNA testing occurred, Kim demanded the bone back. The Sheriff now refuses to return the bone and further demands that Kim give him all the remaining bones for testing. The Sheriff is also refusing to amend the Death Certificate to allow Kim to bury her son's remains. On information and belief, the Sheriff is acting to protect the non-credible report of his alleged expert.
